Terms and Conditions

PRICES, DEPOSIT, AND PAYMENT: \$2989 per rowing participant. If the total number of participants reaches 15, the price per rower becomes \$2749. Non rowing participants deduct \$400 per person. Cost includes 7 nights double occupancy hotel accommodations, hotel taxes and service charges included (single supplement may be available on request), official "welcome" at the Slovenian Rowing Headquarters, coached rowing sessions, video analysis and technique talks with Marlene Royle, boats, oars, full breakfast daily, Welcome Dinner Celebration and Farewell Dinner (alcoholic beverages not included), transportation and entrances on group sightseeing trips arranged by the group leaders, an airport transfer to and from the airport in Ljubljana. Costs are based on exchange rates as of December 7, 2009 and are subject to adjustment in the event of any major currency fluctuation. Cost does not include airfare, travel insurance, hotel tourist tax of €1 per person per day to be paid directly to the hotel, personal items, telephone, travel insurance, tips to guides and drivers.

Enrollment is limited and a \$500 deposit reserves a place on the trip. The balance is payable no later than July 1, 2010.

CANCELLATION POLICY: This trip may be cancelled due to low enrollment or other unforeseen reasons. Full refund will take place only under these circumstances. Regardless of reason, all cancellations must be in writing and are subject to the following cancellation penalties. Travel insurance is highly recommended. Contact Callisto Tours regarding our CSA group protection plans.

- Trip deposit is fully refundable less a \$200 service fee if cancelled before July 1, 2010.
- For cancellation after July 1 and before August 1, 2010 50% of payment is refundable.
- For cancellation after August 2 and before August 18, 2010, 25% of the payment is refundable.
- For cancellation after August 18, 2010 payment is non refundable.

PASSPORT is required for all US citizens and must be valid for at least 6-months following return home. If you do not hold a US passport, please advise your travel counselor and they will check on your travel document requirement.
