**PRICES, DEPOSIT, AND PAYMENT:** \$2750 includes 6 nights double occupancy accommodations in a Tuscan hillside bed and breakfast (single supplement may be available on request), coached rowing sessions, video tape review and technique talks with Marlene Royle, boats, oars, Italian breakfast daily, either lunch or dinner each day (house wine or beer is included, additional alcoholic beverages are not included), all sightseeing arranged by the group leaders, transportation and entrances on sightseeing trips, any wine or cheese tasting or other culinary or cultural event organized by the tour, airport transfer to and from Florence Amerigo Vespucci airport (FLR) (within designated timeframes). The cost is based on exchange rates as of December 7, 2009 and is subject to adjustment in the event of any major currency fluctuation. Cost does not include airfare, personal items, telephone, travel insurance, optional or additional activities by special arrangement, or tips to guides and drivers.

Enrollment is limited and a \$500 deposit reserves a place on the trip. The balance is payable no later than June 15, 2010.

**CANCELLATION POLICY:** This trip may be cancelled due to low enrollment or other unforeseen reasons. Full refund will take place only under these circumstances. Regardless of reason, all cancellations must be in writing and are subject to the following cancellation penalties. Travel insurance is highly recommended. - Trip deposit is fully refundable less a \$200 service fee if cancelled before April 1, 2010.
- For cancellation after April 2 and before July 5, 2010 50% of payment is refundable.
- For cancellation after July 6, 2010 payment is non refundable.
